## Permanently Disabled

A member in good standing who is permanently disabled, and for whom the payment of dues would constitute a hardship, may be classified as a permanently disabled member. "Permanently disabled" shall mean total disability that continuously prevents the member from carrying out substantial and material professional duties; such member must be under the regular care of a physician (other than himself) and may not derive any income or profit from any activity as a podiatrist. A member classified as "permanently disabled" shall not be eligible for any other category of membership. Disability membership shall be revoked if the member's disability has terminated and the member is able to resume activities as a podiatrist.

## Non-Practicing

A DPM who is no longer engaged in practice or in the dispensing of podiatric medical services and who is a member in good standing of NYSPMA may qualify for Non-practicing member status. ## Payment Options

### Monthly Auto-Payment Plan

Members may elect a monthly auto-payment plan subject to a **\$50 administrative fee**. Annual dues are paid over 10 consecutive months (June through March).

- First month's payment must be received no later than June 31st to avoid suspension.
- A lapse of 60 days from the last payment will result in membership suspension.

### Quarterly Auto-Payment Plan

Members may elect a quarterly auto-payment plan subject to a **\$50 administrative fee**. Payments are due at the start of each quarter.

- Due dates: June 1st, September 1st, December 1st, and March 1st.
- A lapse of 60 days from the last payment will result in membership suspension.
- Enrollment closes after July 1st — forms must be completed at the start of the fiscal year.

### Full One-Time Annual Payment

One-time annual payments are due within **60 days of June 1st** to avoid suspension.
